Version June 26th, 2012

Introduction

- 1.1 The China-Europe Water Platform (CEWP) Work Programme 2012-2015 provides the overall framework for the development and implementation of CEWP in the period 2012-2015. It envisages the broad picture for the CEWP in the long term. The Work Programme hereby reflects the joint China-EU ambition level for the CEWP.
- 1.2 The draft CEWP Work Programme 2012-2015 will be prepared by China and Denmark on healf of EU acting as lead countries for the first period of three years starting on March 2012 in cooperation with co-lead countries and organisations interested to participate in the CEWPA. Accordingly, Portugal as first co-lead country will be involved in the preparation of this first version. Furthermore, the EU Delegation to China and Mongolia will be consulted.
- 1.3 The draft will be presented for consultation and feed-back at the EU Water Initiative Multi-Stakeholder Forum to be held in August 2012 in Stockholm in connection with the Stockholm World Water Week Furthermore, EU Member States and other stakeholders will be consulted before the 1st Steering Committee meeting. Finally it will be made available for comment on the CEWP website.
- 1.4 All parties eligible for participation in the CEWP are invited to take responsibility for a certain theme consisting of various activities thereby becoming a co-lead of the CEWP and also to take responsibility for activities to be carried out, whether these activities are included in the current draft work programme or proposed by co-leads.
- 1.5 At the 1st Steering Group meeting, the 2012-15 work programme will be discussed and finally approved. The Work Programme will be revised annually. For the first year, a detailed Work Plan will be developed for approval by the Steering Group Meeting. During the inception phase of the CEWP, i.e. the time up and until the Steering Group Meeting, an Interim Work Plan has been developed.

1 Purpose of work programme

- 2.1 The overall purpose of the CEWP Work Programme 2012-2015 is to achieve the CEWP objectives through concrete activities to enable the successful implementation of the CEWP in the three years following its launch in March 2012.
- 2.2 The specific purpose is as follows:
- To establish the organisation and working mechanisms of the CEWP;
- To continue policy dialogue between China and Europe after completion of the EU China River Basin Management Programme in July 2012 (see http://euchinarivers.org) also looking into synergies with other EU-China policy dialogues (e.g. High level dialogue on Environment, EU China Cooperation Plan in Agriculture and Rural Development, Energy Security, Disaster Risk Management) and the EU-China strategic partnerships, including e.g. the newly launched partnership on sustainable urbanization (see http://ec.europa.eu/commission_2010-2014/oettinger/headlines/news/2012/05/20120503_en.htm)

- To enable / ensure the CEWP produces tangible results in terms of cooperation agreements, policy recommendations and improved practices in water management, and related exchange visits of mutual interest;
- To facilitate strengthening of research co-operation
- To facilitate mutual and joint business development;
- To ensure, together with the CEWP Interim Work Plan, the achievement of selected milestones crucial to the success of the CEWP.

2.3 The proposed milestones are listed in Table 1.

2 Three parts, various themes

- 3.1 It is envisaged that the work programme is divided into three parts each consisting of various themes and activities. The three parts are the following:
 - ➤ Part 1: Policy dialogue. That is, the execution of a policy dialogue concerning the development and subsequent implementation of water sector reforms among stakeholders in China and Europe.
 - ➤ Part 2: Science and technology exchange. That is, partnership and stakeholder cooperation with regard to science and technology in the water sector as a whole (water resources management and monitoring, river basin management, flood management and other water

- relater disasters, irrigation, water resources protection, water supply and sanitation, agriculture/rural development/food security as well as water resource management).
- ➤ Part 3: Programme facilitation. That is, ensuring efficient exchange of lessons learned through, among others, proper monitoring and reporting; further a communication component will ensure easy overview to activities, stakeholders etc
- 3.2 It is foreseen that the lead countries will be overall responsible for Part 1: Policy dialogue and Part 3: Knowledge sharing. With regard to Part 2: Science and technology exchange it is proposed that a country, province and/or institution, whether in China or Europe, takes responsibility for a certain theme, such as ground water, thereby becoming a co-lead of the CEWP. Various implementing units and partners may be involved in the development and implementation of the themes (see below).
- 3.3 Each part has its own objective supporting the achievement of the purpose of the work programme. Each part consists of a set of themes. Table 1 below provides an overview of the three parts, their objectives and their themes.
