Session description -1/2



The session will start with an analysis on how the legal and institutional frameworks at the global, regional, and basin level foster transboundary water cooperation, and discuss the gaps and challenges to cooperation based on the results of the second reporting exercise on SDG indicator 6.5.2. Session participants will then be introduced to the existing international processes, tools, and guidance materials, fostering transboundary water cooperation at the global level. These include: the accession to the global United Nations Water Conventions and the assistance provided by the Convention secretariat in acceding to the Water Convention, including from the perspective of a new Party; the tools and instruments available to different water management actors, such as the recent publication *Agreements for Transboundary Water Cooperation: A Practical Guide* that serves as an agreement-builder. Lastly, the session will proceed to the discussion of the examples of the application of international water law principles in practice at basin and regional levels. This session will thus provide an overview of how to advance transboundary water cooperation stages.

Key objectives

- Highlight the role of legal frameworks in providing an enabling environment for sustainable and integrated water resources management and conflicts prevention, and present concrete tools and instruments that support the development and implementation of such legal frameworks
- Present the experience of the new Parties to the Water Convention, latest developments regarding transboundary water cooperation at the sub-regional and basin level, and analyse the challenges, taking into account the basins with tensions over shared waters;
- Highlight the role the stakeholders can play in fostering progress towards the development and implementation of operational arrangements


